## National Quality Standard 2.2 - Safety

Element 2.2.1 – 'at all times, reasonable precautions and adequate supervision ensure children are protected from harm and hazard'

## **Educator's Vehicle**

Where educators use their own vehicles to transport children in their care:

- a) the vehicle is suitable and safe for all children
- b) the vehicle must be roadworthy and regularly serviced
- c) the vehicle must comply with the appropriate transport regulations including:
  - i. valid vehicle registration certification
  - ii. appropriate seating for each child
  - iii. approved child restraints fitted in accordance with Australian Standards
  - iv. all parts, including the instruction booklet, are readily available
  - v. straps and buckles are in good working order
- d) the driver must:
  - i. hold a current Working With Vulnerable People check
  - ii. hold a valid driving licence for the vehicle
  - iii. not be required to display provisional licence plates
  - iv. have a zero blood alcohol content, and
  - v. not be adversely affected by drugs or medication
- e) the educator to child ratio must be maintained
- f) children are never to be left unattended in the vehicle
- g) loose objects, such as luggage or items on the parcel shelf, are to be stored safely and securely
- h) animals must be secured safely

**Note:** The approved registration body/licensing authority may request an accredited roadworthiness check to be carried out on a vehicle. This cost will be borne by the educator. Educators and educator assistants are to ensure that they have received basic training on how to move and fit car restraints and booster seats correctly.
